

Party City Vendor Price Guide

Vendor Groups

- Group A Vendors that wish to communicate with a VAN
- Group B Vendors that wish to communicate with AS2
- Group C Vendors that wish to trade e-commerce documents using a browser.

Vendor Group A

If a vendor chooses to continue using a VAN connection for exchanging electronic documents with Party City, then the vendor will be responsible for all VAN related and kilocharacter charges (sent and received) incurred by Party City.

The vendor will be responsible for the relationship with the VAN. Party City will require a vendor owned mailbox to send and retrieve data.

Vendor Group B

Communicating with Party City- AS2 licensing fees

- 1. Mandatory software fee for communications with the Party City/ICC Server:
 - \$495, one-time startup fee includes licensing, setup, testing and 1st year's maintenance.
 - \$200/year after the 1st year for annual support.
 - No transaction or VAN fees
- 2. If the customer does not have AS2 capabilities at their location, the additional fee is:
 - \$975, one-time startup fee includes product licensing, technical support for remote product setup, testing with the ICC Server and 1st year's maintenance. An AS2 product will be installed at the customer's location. This is the licensed application component of the offering.
 - \$290/year after the 1st year for annual support.
 - No transaction or VAN fees
